Love Vision Foundation (“we,” “us,” or “our”) is committed to ensuring that our digital platforms are inclusive and accessible to all users, including persons with disabilities. Known Accessibility Limitations

Despite our best efforts to ensure full accessibility, we are aware of the following limitations:

1. **Color & Visual Contrast**

Some text or icon areas may not meet minimum WCAG color contrast ratios.

Planned Action: Standardizing background-foreground contrast across all pages.

2. **Alternative text (Alt-text) Coverage**

Some older uploaded images may lack alternative descriptions.

Planned Action: Running accessibility scans to support full inclusion of alt-tags.

3. **Heading and Structural Hierarchy**

Certain pages may contain non-sequential heading tags, which can affect screen-reader navigation.

Planned Action: Restructuring HTML markup for logical reading order.

If you encounter an issue not listed here, please notify us so that we may correct it.

Technical and Evaluation Approach

Love Vision Foundation assesses website accessibility through the following industry-standard methods:

- Internal accessibility review
- Periodic automated scans through accessibility evaluation tools
- External third-party review (scheduled annually or as significant changes are made to the website)

Where externally audited, results may be made available to stakeholders and partners upon written request, following our internal review process.
